

Consignment Agreement

1. Let's Play accepts only GENTLY used items. All items must be CLEAN, in working condition, WITH BATTERIES (if applicable) and no missing parts. Clothing must be laundered, with NO STAINS OR TEARS. Any imperfect items (items in need of repair or cleaning, or items with missing parts) left for consignment may, without notice, be donated to any charity chosen by Let's Play, LLC. Let's Play no longer accepts any bedding items (bumpers, sheets, comforters, etc.)
2. Let's Play, LLC will determine pricing for all consigned items. Markdowns will be made on all consigned merchandise as deemed necessary by Let's Play.
3. Let's Play may also offer other discounts on merchandise at any time for sales and special events.
4. Forty percent (40%) of the selling price of each item will be paid to the Consignor. Consignment pay-outs are issued monthly for the previous whole month. Pay-outs must be picked up by the Consignor, or another authorized person as listed on the Consignor's account. Pay-outs will not be given to anyone that is not listed on the consignor's account. Pay-outs may also be issued at other times, at the request of the Consignor, but only with the approval of Let's Play management.
5. Consignor has six (6) months from the date of issue to claim any consignment pay-outs. Consignor forfeits all rights to any account balances or consignment pay-outs not collected within this six (6) month time frame.
6. Let's Play, LLC assumes no responsibility for the loss (theft) or damage of any consigned items.
7. The Consignor is committed to a three (3) month consignment period, beginning on the first day of the month following the date of merchandise drop-off. Consignor must pick up all unsold consignments within five (5) days from the date of expiration of the consignment term. Any items that are not picked up within this time frame will, without further notice, become the property of Let's Play, LLC, and may be donated or disposed of by Let's Play, LLC. Let's Play, LLC reserves the right to remove any item(s) from consignment, for any reason, prior to the end of the consignment term, in which case the Consignor will be notified and given a time frame to pick up the item(s).
8. Holiday merchandise (Christmas, Easter, Halloween, etc.) must be picked up within 14 days following the holiday. Any holiday merchandise not picked up within this time frame will, without further notice, become the property of Let's Play, LLC, and may be donated or disposed of by Let's Play, LLC.
9. Due to space constraints, Let's Play may not be able to accept large items such as strollers, cribs, swings, etc. In this case, Let's Play will offer a ninety (90) day posting on our "For Sale" bulletin board, consisting of a picture and contact information, as well as a text listing on our web site, for a one time fee, payable in advance, of twenty percent (20%) of the listed price of the item. This fee is non-refundable, even if the item does not sell within the ninety (90) day posting period.
